FSC®: The highest standard in responsible fiber sourcing

■ What is FSC®?



The Forest Stewardship Council® (FSC) is an international, non-governmental organization dedicated to promoting responsible management of the world's forests. FSC:

- created in response to public concern about deforestation
- developed a proven system of forest certification and product labeling
- allows consumers to identify wood and wood-based products from well-managed forests or from post-consumer waste

■ What is the FSC Mix Label?

The FSC label looks at both virgin and recycled fiber, ensuring the fiber has been sourced according to FSC's high standards of social and environmental responsibility.

■ What does it protect?

FSC prohibits deforestation, including conversion of natural forests to plantations. It also protects rare old growth, high conservation values (HCVs), and rare, threatened and endangered (RTE) species.

■ How does Kimberly-Clark Professional partner with FSC?

- 100% of the fiber used in our towels is from premium recycled paper, Forest Stewardship Council® (FSC®) Certified or FSC® Controlled Wood sources
- In 2009, Kimberly-Clark Professional became the first away-from-home tissue products company to receive FSC chain-of-custody certification for a broad range of tissue and towel products
- 99% of Kimberly-Clark Professional's towel and tissue portfolio is FSC certified
- Kimberly-Clark Professional WypAll® L10 and L20 series wipers are FSC certified

ECOLOGO: One of the most rigorous environmental standards for manufacturers

What is ECOLOGO?



ECOLOGO Certifications are multi-attribute environmental certifications that indicate a product has undergone rigorous scientific testing, exhaustive auditing, or both, to demonstrate compliance with stringent environmental performance standards.

- Is one of North America’s most respected product sustainability certification programs
- Is based on multi-attribute, life cycle-based standards

To earn the ECOLOGO mark, products must demonstrate significantly reduced environmental impact including energy reduction, materials, energy, manufacturing and operations, health, and environment.

What are the benefits?

The ECOLOGO program offers credible third-party certification of products and services to build and strengthen trust between buyers and suppliers, and customers and manufacturers. Its standards offer both environmental leadership and human health and safety criteria that are scientifically developed, multi-stakeholder reviewed and robustly vetted.

What does this mean for Kimberly-Clark Professional products that are certified by ECOLOGO?

- Towel and tissue products that are ECOLOGO certified contain a minimum of 50% recycled fiber content and any remaining virgin fiber comes from a third-party certified responsible source
- Skin care products that are ECOLOGO certified are free from dyes and fragrances, aim to maintain or improve environmental quality through reduction of energy and materials consumption, and minimize the impacts of pollution generated by production and disposal of goods and services



Criteria includes:



Rigorous standards relating to limiting chemicals of concern



Allows for the use of responsibly procured recycled and virgin fiber



Defines specific metrics around solid waste going to landfill



Tracks the quality of the water put back into the ecosystem with requirements on specific quality tests



Requires energy consumption data and rewards manufacturers for good/better/best performance



Includes a very thorough audit of the manufacturing system’s ability to control quality

Environmental Protection Agency (EPA): Minimum guidelines on post-consumer waste

■ What is the EPA's Comprehensive Procurement Guideline program?

The Comprehensive Procurement Guideline (CPG) program ([learn more here](#)) is part of the EPA's Sustainable Material Management initiative that promotes reduction of materials usage, greenhouse gas emissions, and other environmental impacts over a materials' entire life cycle.

- Promotes usage of materials recovered from municipal solid waste streams.
- Ensures materials collected in recycling programs will be used again in the manufacturing of new products.

EPA's Recovered Materials Advisory Notes (RMAN) recommends procuring agencies establish minimum content standards expressed as a percentage of recovered fiber.

■ What does this mean for Kimberly-Clark Professional products that meet the EPA's minimum post-consumer waste guidelines?

- Paper towels that meet EPA guidelines contain a minimum of 40% post-consumer waste
- Bath Tissue that meet EPA guidelines contain a minimum of 20% post-consumer waste
- Facial Tissue that meet EPA guidelines contain a minimum of 10% post-consumer waste
- Paper napkins that meet EPA guidelines contain a minimum of 30% post-consumer waste
- General purpose industrial wipers that meet EPA guidelines contain a minimum of 40% post-consumer waste



ASTM D6868 Standard: Outlines criteria that must be met to confirm compostability

■ What is the ASTM D6868 standard?

Products that meet ASTM D6868 standard have demonstrated the ability to safely breakdown in a professionally managed industrial or municipal composting facility.

■ What are the benefits?

Workplace composting programs support sustainability, waste reduction, and zero waste initiatives.

■ What does it mean for Kimberly-Clark Professional products that meet ASTM 6868 standard*?

- 98% of Kimberly-Clark Professional North America's paper towel portfolio can be diverted from landfill via composting*
- Kimberly-Clark Professional L10 and L20 white wipers can be aerobically composted in municipal or industrial facilities in United States and Canada*
